- 8. The Anti-Sexual Harassment committee may, depending on the nature and gravity of the guilt, to those found guilty, one or more of the following punishments, namely;
  - a) Suspension from attending classes and academic privileges.
  - b) Debarring from appearing in any test /examination or other evaluation process.
  - c) Cancellation of admission.
  - d) Withholding/withdrawing scholarship/fellowship and other benefits.
  - e) Debarring from representing the institution in any national or international meet, tournament, youth festival etc.
- 9. I hereby affirm that, if found guilty of sexual harassment, I am liable for punishment according to section 14 of the 2013 Act of the Regulations, without prejudice to any other criminal action that may be taken against me under any penal law or any law for the time being in force.
- 10. I hereby declare that I have not been expelled or debarred from admission in any institution in the country on account of being found quality of, abetting or being part of conspiracy to promote, sexual harassment; and further affirm that, in case the declaration is found to be untrue, I am aware that my admission is liable to be cancelled.
