2. I have also, in particular, perused the regulations and am fully aware of the penal and administrative action that is liable to be taken against me in case of the following cases.
3. I will not indulge in any form of sexual harassment be it physical, verbal or non-verbal.
4. I will not indulge in any physical forms of sexual harassment such as unwanted contact, ranging from intentionally touching, caressing, pinching, hugging or kissing to sexual assault or rape.
5. I will not indulge in any verbal forms of sexual harassment that includes socially and culturally inappropriate and unwelcome comments with sexual overtones such as sexually suggestive jokes or comments about a person’s dress or body, made in their presence or directed toward them. They also include persistent proposals and unwelcome requests or persistent personal invitations to go out.
6. I will not indulge in any kind of non-verbal form of sexual harassment including unwelcome gestures, suggestive body language, indecent exposure, lascivious looks, repeated winks and gestures with fingers. It also includes the unwelcome display of pornographic materials, sexually explicit pictures and objects, screen savers or posters as well as sexually explicit e-mails, notes or SMS messages.
7. I hereby solemnly aver and undertake that
  - a) I will not indulge in any behaviour or act that may be constituted as sexual harassment under clause 3(1) of the Regulations.
  - b) I will not participate in or abet or propagate through any of commission or omission that may be constituted as sexual harassment under clause 3(1) of Regulations.
8. The Anti-Sexual Harassment committee may, depending on the nature and gravity of the guilt, to those found guilty, one or more of the following punishments, namely;
  - a) Suspension from attending classes and academic privileges.
  - b) Debarring from appearing in any test /examination or other evaluation process.
  - c) Cancellation of admission.
  - d) Withholding/withdrawing scholarship/fellowship and other benefits.
  - e) Debarring from representing the institution in any national or international meet, tournament, youth festival etc.
9. I hereby affirm that, if found guilty of sexual harassment, I am liable for punishment according to section 14 of the 2013 Act of the Regulations, without prejudice to any other criminal action that may be taken against me under any penal law or any law for the time being in force.
10. I hereby declare that I have not been expelled or debarred from admission in any institution in the country on account of being found guilty of, abetting or being part of conspiracy to promote, sexual harassment; and further affirm that, in case the declaration is found to be untrue, I am aware that my admission is liable to be cancelled.
