- 1. Approval of agenda: Accepted

A meeting of the IQAC was held in D11 on Thursday, 17/10/2019 from 2:30 pm to 4:30 pm. The coordinator, Mrs. Sangeetha welcomed the members to the second meeting of the IQAC for the academic year 2019-2020.

- 1. Approval of agenda: Accepted
- 2. Confirmation of Minutes of Meeting of the previous IQAC Meeting: The Minutes of the previous IQAC meeting were read, accepted and approved by all the members. With reference to the resolution passed in the previous meeting, agenda discussion no. 4, where the faculty members must attend subject and skills related workshops/orientation, Ms. Sangeetha J attended "FACULTY DEVELOPMENT PROGRAM ON "APPROACHES TO THE NEW ENGLISH TEXTBOOK" VVN DEGREE COLLEGE on 10th August 2019.
- 3. Result Analysis of the Previous Semester: The University exam result of May/June 2019 stood at 83.72%. The overall pass% of the Institution for the academic year 2018-19 was 80.47% (Nov 2018 77.22% and May 2019 83.72%). The Chairperson appreciated that the pass % has crossed the set target of 77%. The increase from the last year to this year is 7.04% which is better as compared to the last year increase of 3.24%. Again it is significantly lesser than the first year hike of 11%. Hence it still needs improvement. The target for this academic year was set at 82%.

4. NAAC Progress - Criterion 1 - Curricular Aspects:

Ms. Sangeetha, the Criterion head for Criterion 1 - Curricular Aspects presented her file for the review of the committee. The following amendments were to be made:

1. The analysis for all the Value Added Programs must be done separately for Attitude and Behavioral Development Program as it is offered to all the students As well as the Certificate Programs will be offered for the Global and

Professional Students. This was challenging to get the accurate % of the value added programs offered.

- 2. Year wise Feedback for the Value added programs that are available in table format must be graphically represented for all the 5 years.
- 3. To include case studies for experiential learning.
- 5. Discussion on the events conducted by various committees: The various committee coordinators submitted the report on the activities conducted through their respective committees during the year and also submitted the future plan of action for their committees.

Internal Quality Assurance Cell Minutes of the Meeting

Date: 5th March 2020

A meeting of the IQAC was held in Room No. D11 on Thursday, 05/03/2020 from 2:30 pm to 4:30 pm. The coordinator, Mrs. Sangeetha welcomed the members to the third meeting of the IQAC for the academic year 2019-2020

- 1. Approval of agenda: Accepted
- Confirmation of Minutes of Meeting of the previous IQAC Meeting: The Minutes of the previous IQAC meeting were read, accepted and approved by all the members.
- 3. Result analysis of the previous semester: The pass % of November/December 2019 University exam was 80.95%. Again there is an increase from the Nov/Dec 2018 exam where the pass% was only 77.22%. However, the target of 82% for the academic year must be kept in mind and hence the result for the next semester cannot be anything less than 85%. The remedial classes must be strictly monitored and the attendance defaulters must be dealt sternly.
- 4. Academic Planning for the next academic year: The Chairperson, the IQAC Team and the Heads of the Departments drafted the calendar of events for the year with due consideration to the University calendar of events. The dates for various events like orientation programs, internal examinations and improvement tests were scheduled. Various activities to be conducted for the year like seminars, conferences, workshops, industrial visits and extension activities were also drafted.
- 5. Feedback analysis conducted for the previous year: The IQAC coordinator presented a detailed analysis of the feedback of all the events conducted for the previous year to the Chairperson and the Team Members. The chairperson suggested a few corrective measures for a few events based on the feedback analysis presented and informed that the future events must be planned and organized based on these suggestions.

- 6. Review of progress in NPTEL and MOOC Registrations: The registration by students and faculty members for NPTEL/MOOC Courses were reviewed by committee. The Chairperson was happy to see a reasonable improvement in the number of registrations by the students. She also advised the Heads of the Departments to constantly encourage the students for more registrations and make them aware of the benefits of these courses.
- 7. NAAC Progress Criterion 7: After reviewing the file submitted by the Criterion Head, Ms. Divya Baliga, it was suggested that although the NAAC asks the description for two best practices, it is recommended to few more Best Practice followed by the Institution. Ms. Divya to include the same and submit to the Committee.
- The write-up for 7.3 Institutional Distinctiveness to be re-framed highlighting the contribution of the Institution towards holistic and professional development of the students.
- 8. Suggestion by external members: Mr. Santhosh suggested that in order to encourage more students to register for these short term courses, it would be highly recommended to award a portion of internal marks for registering and completing one course in a semester. This suggestion was wholeheartedly approved by all the members and the Chairperson asked the Heads of the Departments to implement the same.
